HERBERT J. P. SULLIVAN, 0-405772, Captain, CAC, AAA Gun Battalion, for gallantry in action near Cima Pongoira, Italy on 17 October 1944. From an exposed forward observation post Captain Sullivan was adjusting artillery fire on enemy positions when the enlisted man assisting him received penetrating wounds of the head. Although fully exposed to the enemy's fire he administered first aid and with the help of an enlisted man, succeeded in evacuating the wounded man down the face of a forty foot cliff to where further evacuation could be effected by litter. While in this position they received a second concentration of enemy mortar fire. Unmindful of his own safety Captain Sullivan covered the injured man with his own body in order to protect him from further injury by the flying rock fragments and shrapnel. By his gallantry and devotion to his men Captain Sullivan reflects credit upon himself and the United States Army. Entered the service from Dorchester, Massachusetts.

JAMES Y. MIZUNO, 0-1695699, Second Lieutenant, FA, Battery "B", \*\*\* Field Artillery Battalion, for gallantry in action near LaHoussiere, France, on 5 November 1944. Assigned the task of attacking and clearing a strongly held ridge, the company with which Lieutenant Mizuno was serving as forward artillery observer advanced against the enemy through heavy mortar, artillery, and machine gun fire. Although painfully wounded during the action in the right shoulder, he crawled 400 yards over difficult and open terrain to obtain aid for his more seriously wounded radio operator. After receiving hasty first aid treatment he returned to his forward position and continued to direct the effective artillery fire. Lieutenant Mizuno's initiative, determination, and courageous action in the face of extreme danger contributed immeasurably in the subsequent attainment of the objective. Entered the service from Los Angeles, California.

FRANK S. OKUSAKO, 0-1693640, Second Lieutenant, Inf., Company "H", \*\*\*
Infantry Regiment, for gallantry in action near Bruyeres, France on 20 October 1944.
When a food and ammunition carrying party was ambushed by a superior enemy force,
Lieutenant Okusako led an 8-man patrol to the aid of the entrapped soldiers. While
encircling the enemy's position for an attack on the rear the patrol encountered
another enemy force of 45 men, armed with machine guns, machine pistols, grenades,
and light arms. Constantly exposing himself to the enemy fire Lieutenant Okusako
fearlessly directed the fire and movement of his men, killing fifteen of the enemy
with his own machine gun and neutralizing two enemy machine gun nests with rifle
grenades. Although severely wounded in the chest and shoulder, he continued to
encourage his men until forced by the severity of his injuries to retire to the
aid station. By his gallantry, courage and superior tactical leadership Lieutenant Okusako inspired his men to hold off a numerically superior enemy and played an
important part in freeing the supply route of the enemy's forces. Entered the
service from Newcastle, California.

I -- AWARD, POSTHUMOUS, OF THE SILVER STAR. By direction of the President, under the provisions of Army Regulations 600-45, 22 September 1943, as amended, the Silver Star is awarded, posthumously, by the Army Group Commander to the following named individuals:

JAMES K. UEJO, 30102129, Corporal, Inf., Company "D", 100th Battalion, \*\*\*\* Regimental Combat Team, for gallantry in action near Biffontaine, France on 28 October 1944, during an attack against an enemy-held hill. Disregarding the heavy enemy artillery and mortar fire that had wounded three of his comrades during the action, Corporal Uejo made his way to the injured men and rendered first aid. Upon observing that one was in need of immediate evacuation he unhesitatingly left his position to contact a litter team of an adjaceant unit and while leading it back to the position was fatally wounded by a mortar shell. By his outstanding loyalty to his unfortunate comrades and self-sacrificing efforts Corporal Uejo reflects great credit upon himself and the armed forces of the United States. Next of kin: Mrs. Kane Uejo (Mother), P. O. Box 56, Kalaheo, Kauai, Territory of Hawaii.

NOBUAKI TOMITA, 30105865, Private First Class, FA, Battery "B", \*\*\* Field Artillery Battalion, for gallantry in action near LaHoussiere, France on 5 November 1944. Assigned the task of attacking and clearing a strongly held ridge, the company with which Private First Class Tomita was serving as radio operator advanced against the enemy through heavy mortar, artillery, and machine gun fire. Upon observing that the forward observer and assistant radio operator had been wounded he left his place of comparative safety and determinedly worked his way to within 60 yards of the enemy, to evacuate the more seriously wounded of the two man. He then remained with the forward elements, efficiently and fearlessly manning his radio under continuous and concentrated hostile fire until mortally wounded the next morning. By his courage, initiative, and determination Private First Class Tomita reflects much credit upon himself and the United States Army. Next of kin: Mrs. Toki Tomita (Mother), Lanai City, Lanai, Territory of Hawaii.

KENICHI TSUMAKI, 39683559, Private First Class, Inf., Company "K", \*\*\* Regimental Combat Team, for gallantry in action in France on 29 October and 7 November 1944. When his company's radio was damaged by enemy hand grenade fragments, Private First Class Tsumaki volunteered to carry a new one to the forward company. Though the artillery shells were falling along the supply route, he valiantly moved forward toward the front lines, crawling through enemy small arms fire for the last 75 yards to successfully reach his destination. On 7 November 1944, when the company was badly in need of ammunition he voluntarily carried two boxes of ammunition for a distance of 150 yards through heavy enemy fire to the front



Battalion, was a forward observer attached to my company on
5 November 1944 near LaHOUSSIERE, FRANCE. My company was spearheading the attack of the battalion and our first mission was to
clear a strongly held ridge. The character of the terrain offered
little observation and Lt Mizuno voluntarily accompanied the
assault platoon to render maximum artillery support for our advance.
Our progress was slow as the enemy directed a withering small arms
and machine gun fire from dug in positions and continuous artillery
and mortar shells rained down upon our forces. During the course
of the attack, Lt Mizuno, on numerous occasions worked his way
forward courageously and at one time up to within 60 yards of the
enemy to direct effective artillery fires upon enemy strongpoints.
It was during one of these audacious movements that he was painfully wounded, but remained with the most forward elements, considering only the mission to be performed until I personally
ordered him to withdraw to receive proper medical treatment.
Lt Mizuno's display of outstanding bravery, determination, initiative and cool efficiency in the face of extreme danger aided
